BUTTE COUNTY'S GROUNDWATER PUZZLE: HOW THE PIECES FIT

AAUW advances gender equity for women and girls through advocacy, education, and research.

The League of Women Voters of Butte County and Chico AAUW are hosting a forum on an issue of great significance to our region. The League supports measures that promote the development and management of water resources in ways that protect the environment, strengthen the local economy, and enhance quality of life—while recognizing that hydro-geologic boundaries do not follow political lines. Their Natural Resources Committee has been hard at work collaborating with several of our AAUW branch members to develop a program on the status and sustainability of Butte County groundwater resources.

A panel of experts will explain the importance of conserving the aquifer from which Chico gets its water, what is being done to achieve sustainability, and the various interests involved. Speakers include

Christina Buck, Ph.D., Butte County Department of Water and Resource Conservation

Becky Fairbanks, Grants Project Manager, Vina GSA

Jim Brobeck, Water Policy Analyst, AquAlliance

Tovey Giezentanner, General Manager, Tuscan Water District

This is your opportunity to better understand not only the science of aquifers and sub-basins but to learn what is being done in Butte County and how it is viewed by some important stakeholders. There will be time for questions and answers at the conclusion of the presentations. The meeting is free and open to the public. Please plan to attend and invite a friend or neighbor to come with you. When we are informed about the issues of the day, we can help influence better public policy, and a better future for all of us.

The Women's Microfinance Collaborative (WMC) is having its annual meeting in January. The Collaborative started in 2006 with the support of members from many women-focused organizations in Chico (AAUW, Chico Women's Club, League of Women Voters, Soroptimists, and Business and Professional Women). AAUW has perpetuated the effort through the WMC interest group. Since that time, WMC has partnered with Friendship Bridge, a 501(c)(3) organization dedicated to empowering women and eliminating poverty in Guatemala. We have a giving circle supported by free-will donations from interested members. Since our founding, members have contributed more than \$60,000 to set up small community trust banks. Through these banks, women receive resources to create their own solutions to poverty for themselves, their families, and their communities.

Foreign Policy Discussion Group

What will happen in 2026 with tariffs and the world economy? How will US-China relations evolve? What is the future for Ukraine and European security? How will the United States engage with African countries? All of these issues and more will be discussed by the Foreign Policy Discussion Group in the coming year. The group meets in member's homes at 6:30 pm on the 4th Monday of the month to learn about what is happening in our world and to discuss how the United States is using its influence to affect the future of the planet and its inhabitants.

We dive into each issue with the assistance of a study guide prepared by the Foreign Policy Association. Each member takes on one topic a year to do a more in-depth investigation, look for up-to-date information, and lead the discussion. We often learn about the history of an issue and past actions by our government as a backdrop for understanding current options. If you want to have more than a cursory knowledge about foreign policy and really understand the issues, we welcome you to the group. Discussion topics will be selected at the January meeting for 2026. There are 8 topics and 12 months so we do take time off throughout the year. Time commitment is several hours each month to read the study guide prior to the meeting. You decide how much time to devote to the topic when you lead the discussion. MEMBERSHIP

Do you know someone who would love to join our merry AAUW band but doesn't quite meet the degree requirement? Never fear, there is a way!

An applicant must have an associate degree (2 years) or higher from an accredited institution. An R.N. degree also meets this requirement.

Many AAUW members would like this degree requirement to disappear, opening membership, instead, to anyone who wants to work for our mission of advancing equity through education and advocacy. Recent member-wide elections produced an almost, but not quite, majority wishing to overturn the requirement. We may have a chance to vote for it again so stay tuned for my (short and charming) essay on why this would be good for everyone. And fair.

However, right now there is a way to include those who don't quite have the appropriate degrees.

1. A request for an *equivalent membership* may be submitted—either by the prospective member or a member of the branch—to AAUW's CEO (executive@aauw.org or connect@aauw.org).
2. All prospective members should be committed to working to advance equity for women and girls.
3. Whether the eligibility is accepted or not depends on
 - a. Certificates, licenses, or professional certifications issued by accredited institutions of higher education (often found in "adult education" programs). Until recently these institutions had to be approved by the US Dept. of Education but, since the DoE is being eliminated, who knows?
 - b. At least two years of full-time, or 48 credit hours, equivalent education at an accredited institution.
4. A denial of equivalency may be appealed by the "original requester to the AAUW Board of Directors. Decisions of the Board are final.
5. There may be, also, a path to membership through significant work experience.

An equivalency will require documentation but, surely it is worth digging those out to be part of AAUW Chico.

Public Policy

DISMANTLING THE DEPARTMENT OF EDUCATION

Recently the Trump administration took a major new step to dismantle the US Department of Education (DoE). After deep staff cuts, it announced six “partnerships” on November 18 that shift the day-to-day work of key education programs to other federal agencies, despite Congress creating DoE to centralize federal education expertise and protect students’ civil rights. AAUW released a statement underscoring what’s at stake and rejecting the idea that education should be reduced to workforce development alone. Here’s a quick summary of the announcement.

What AAUW has done

Pushed lawmakers to act. AAUW has joined in a multi-organization statement to Congress calling on lawmakers to reclaim their authority and block this unprecedented transfer of ED responsibilities.

Joined actions of disability rights coalitions. Joined shared disability rights principles affirming that DoE must remain an independent, fully staffed and funded agency to oversee the federal education rights of children and youth with disabilities. The **Individuals with Disabilities Act (IDEA)** and Section 504 guarantee students with disabilities a free, appropriate public education and protection from discrimination. Weakening DoE’s capacity to enforce these laws would put those rights—and the resources schools need to uphold them—at risk.

Why this matters

Ensuring civil rights protections in education. DoE was created by Congress to ensure equal educational opportunity and enforce civil-rights laws in education. Scattering expertise across agencies not centered on education makes those statutory responsibilities harder to meet and accountability harder to track.

Preserving the purpose of education. When federal leaders frame education as a “talent pipeline,” they focus on a kind of economic rationality that ignores its broader purpose of preparing people to lead, participate in democracy, and build economically secure lives. That broad purpose is especially vital for women and girls, students of color, LGBTQ+ students, students with disabilities, Native students, immigrants, and others.
